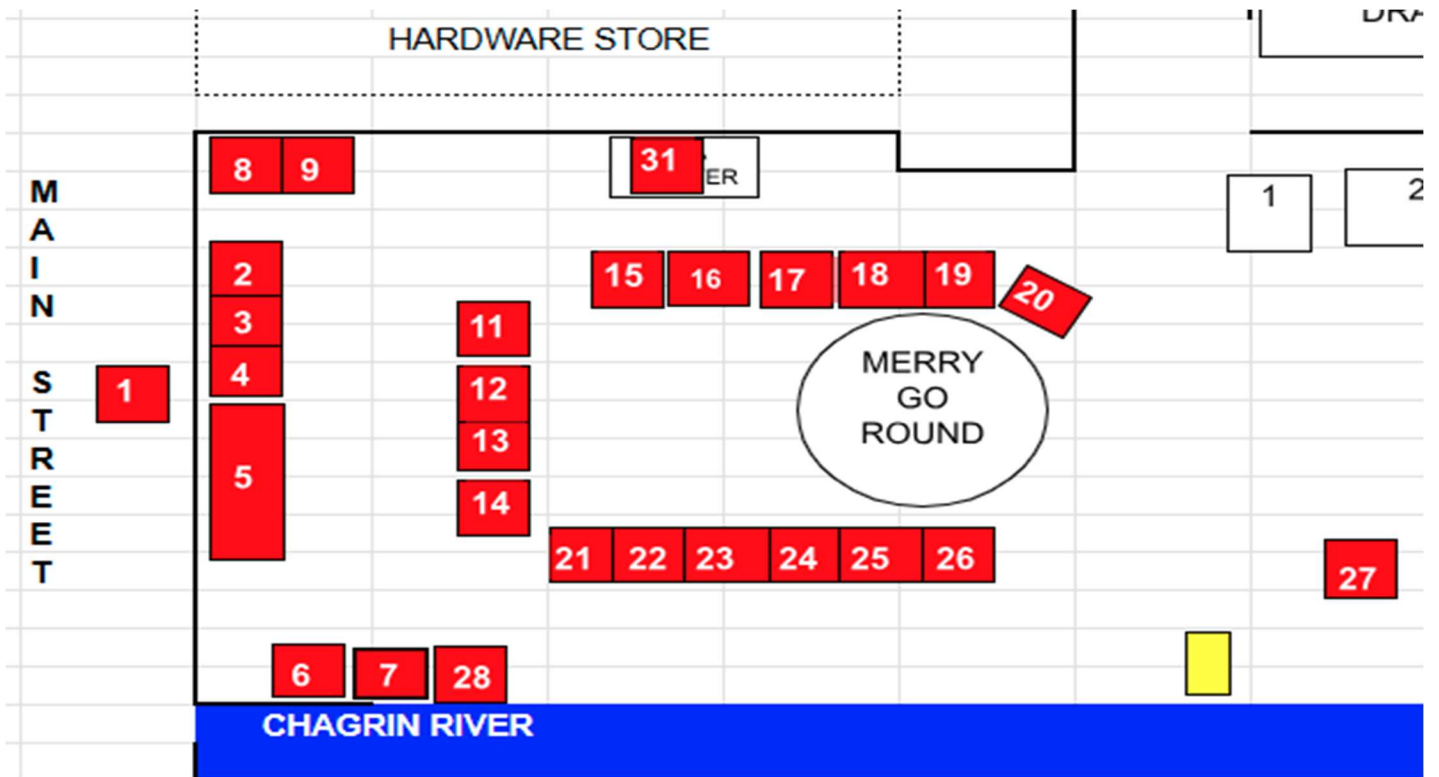

**Insurance and Hold Harmless**

The Lessee is required to carry Commercial General Liability Insurance. The Lessee further agrees to indemnify and hold harmless the Chagrin Valley Jaycees from any claims, demands, liabilities, and cost or attorney fees arising from, or in any way connected with, the Lessee's booth at The Blossom Time Festival. Items of questionable nature will not be displayed or sold. Any acts or practices that are objectionable to the Chagrin Valley Jaycees will cause Lessee to forfeit all rights and privileges of this contract without recourse. Lessee is prohibited from assigning, subletting or otherwise transferring a space that has been allotted to them. The exact location of a booth may differ from the map above. The Chagrin Valley Jaycees reserve the right to move booth locations if necessary. No refunds once payment is made to reserve a booth.
